### ONLINE TRAINING PROGRAMME ON WASTE MANAGEMENT- SWACHH BHARAT MISSION

**The COVID19** pandemic has forced us to do things differently in almost every aspect of our lives. Training and capacity building, which is essential for continuous learning and innovation, will also have to change.

We at the **International Forum for Environment, Sustainability and Technology (iFOREST)** in collaboration with **Sustainability Innovations and Advisories (SIA) Private Limited** (our knowledge partner) have developed a new innovative methodology to conduct an online training programme on

Integrated Waste Management- Swachh Bharat Mission (30th August to 3rd September 2021)

The programme is designed exclusively for the official and local bodies engaged in Swachh Bharat mission. The aim of the training is to build the capacity of local bodies to design and plan affordable, replicable and sustainable waste management practices.

The programme will also help local bodies to develop village and city-level Detailed Project reports (DPR), waste inventory, map resource requirement and select suitable waste treatment options through a participatory approach. The programme will also equip them with skills to use digital platform for data collection, planning, and execution of solid and liquid waste management schemes.

### The core of our innovative on-line method of training is:

**Andragogy:** Our training is designed for adult e-Learning. We use a mix of online lecture, assignments, discussion and demonstration to transfer knowledge and skills effectively.

**Learning on the job:** our training programmes are customised so that a participant needs to devote only 3 hours a day on training (3 hours lecture, class exercise and home assignment). This allows the participant to manage training and job together.

**Individual learning and assessment:** The training programmes are tailored for a small group (25-30 participants) to enable personalized learning and assessment.

**Online demonstrations and videos:** We enhance learning through online demonstrations and customized videos.

### **Training Fees:**
