ONLINE TRAINING PROGRAMME ON LAND ACQUISITION, REHABILITATION AND RESETTLEMENT

The **COVID19** pandemic has forced us to do things differently in almost every aspect of our lives. Training and capacity building, which is essential for continuous learning and innovation, will also have to change.

The five days training programme aimed at giving practical exposure to participants on various provisions Central act (right to Fair Compensation and Transparency in Land acquisition, rehabilitation and resettlement act, 2013) and State rule. The objective of this programme is to build a trained professional who can conduct and review Social impact assessment reports.

The programme will also impart understanding of the issues and challenges in land acquisition, enhance skills in socio-economic surveys, consultations, data collection, planning land acquisition, estimation of compensation, development entitlement, estimation of rehabilitation package.

The core of our innovative on-line method of training is:

Andragogy: Our training is designed for adult e-Learning. We use a mix of online lecture, assignments, discussion and demonstration to transfer knowledge and skills effectively.

Learning on the job: Our training programmes are customised so that a participant needs to devote only 3 hours a day on training (3 hours lecture, class exercise and home assignment). This allows the participant to manage training and job together.

Individual learning and assessment: The training programmes are tailored for a small group (25-30 participants) to enable personalized learning and assessment.

Online demonstrations and videos: We enhance learning through online demonstrations and customized videos.

- Land rights and governance
- Case studies - How land conflicts delay development projects
- Understanding of various provisions of LARR Act
- SIA - Overview, how to develop terms of reference, preparation of land acquisition plans, tools and mechanisms to conduct socio-economic survey, filling socio-economic survey questionnaires, collation and interpretation of data, and categorization of impact and determining its significance.
- Asset evaluation (movable and immovable property)
- Estimation of compensation and rehabilitation package as per the new Act
- Development of entitlement framework, budgeting and grievance redressal
- Development of village-level development plan & gender inclusion, livelihood restoration
- SDG goals and their integration in project planning and operation
- Learning from best practices—management of common property resources (CPR)
- Learning from case studies—relocation and rehabilitation of non-title holders
- Development and review of SIA reports
- Multilateral Safeguards policy (The World Bank & ADB) and how banks ensure compliance.
